Peppers' cellular phone was later retrieved from his person and searched following authorization from the Courts. A review of Peppers' phone revealed photographs of himself and Copeland wearing identical clothing as two individuals observed on the Autohaus burglary surveillance footage posing with large stacks of United States Currency that are time stamped during the timeframe of the burglary. Also found were pictures of vehicles and a key fob stolen during the burglary as well as conversations about the burglary.
