(Conspiracy - Second Degree)

QUAMIR HODGES

and

#### DION WIGGINS

who are named as defendants herein, and other persons whose identities are unknown to the Grand Jurors, who are named as coconspirators but not as defendants herein, between on or about September 7, 2021, and on or about December 22, 2021, at the City of Newark, in the County of Essex, at the Borough of Franklin Lakes, in the County of Bergen, at the City of Jersey City, and at the City of Union City, both in the County of Hudson, at the City

of Linden, in the County of Union, at the City of Margate City, in the County of Atlantic, at the Community of Colonia, in the County of Middlesex, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crime of Receiving Stolen property, did agree that:

- A. One or more of them knowingly would engage in conduct which would constitute the aforesaid crimes; or
- B. One or more of them knowingly would aid in the planning, attempt, solicitation or commission of said crimes, that is:
  - 1. did knowingly or purposely commit theft by receiving or bringing into this State moveable property of another having a value in excess of \$75,000, contrary to the provisions of N.J.S.A. 2C:20-7; and
  - 2. did unlawfully take, or exercise unlawful control over, movable property of another with purpose to deprive him thereof, having a value in excess of \$75,000, contrary to the provisions of N.J.S.A. 2C:20-3;

All in violation of  $\underline{\text{N.J.S.A.}}$  2C:5-2, and against the peace of this State, the government and dignity of the same.

#### COUNT TWO

(Receiving Stolen Property - Second Degree)

who are named as defendants herein, and other persons whose identities are unknown to the Grand Jurors, who are named as coconspirators but not as defendants herein, between on or about September 7, 2021, and on or about December 22, 2021, at the City of Newark, in the County of Essex, at the Borough of Franklin Lakes, in the County of Bergen, at the City of Jersey City, and at the City of Union City, both in the County of Hudson, at the City of Linden, in the County of Union, at the Borough of Shrewsbury, in the County of Monmouth, at the City of Margate City, in the County of Atlantic, at the Community of Colonia, in the County of Middlesex, elsewhere, and within the jurisdiction of this Court, did commit theft by knowingly receiving or bringing into this State moveable property of another, that is, a 2020 Ford Mustang GT, with a Vehicle Identification Number ending in "6006"; a 2019 Dodge Durango RT, Vehicle Identification Number ending in "4826"; a 2019 Audi Q8, with a with a Vehicle Identification Number ending in "7265"; a 2020 Land Rover Range Rover Sport, with a Vehicle Identification Number ending in "3418"; a 2019 GMC Sierra Denali, with a Vehicle Identification Number ending in "8398"; a 2021 Jeep

Gladiator, with a Vehicle Identification Number ending in "9792"; and a 2020 Jeep Grand Cherokee SRT, with a Vehicle Identification Number ending in "7859," and having a value in excess of \$75,000, knowing the same to be stolen or believing that they had probably been stolen, contrary to the provisions of N.J.S.A. 2C:20-7, N.J.S.A. 2C:20-2, and N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

## COUNT THREE

(Theft by Unlawful Taking - Second Degree)

QUAMIR HODGES

and

#### DION WIGGINS

on or about November 14, 2021, at the City of Margate City, in the County of Atlantic, elsewhere, and within the jurisdiction of this Court, did unlawfully take or exercise control over the movable property of another, that is a 2020 Land Rover Range Rover Sport, with a Vehicle Identification Number ending in "3418," having a value of greater than \$75,000, with purpose to deprive the owner thereof, contrary to the provisions of N.J.S.A. 2C:20-3(A), and N.J.S.A. 2C:2-6, and against the peace of this State, the government, and dignity of the same.

## COUNT FOUR

(Conspiracy - Third Degree)

on or about December 6, 2021, at the Borough of Shrewsbury, in the County of Monmouth, and at the City of Jersey City, in the County of Hudson, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crimes of Receiving Stolen Property and Fencing (Dealing in Stolen Property), did agree that:

- A. One or more of them knowingly would engage in conduct which would constitute the aforesaid crimes; or
- B. One or more of them knowingly would aid in the planning, attempt, solicitation or commission of said crimes, that is:
- 1. did knowingly receive or bring into this State movable property of another, valued at more than \$500 but less than \$75,000, knowing that it has been stolen, or believing that it is probably stolen, contrary to the provisions of N.J.S.A. 2C:20-7a; and

2. did traffic in, or initiate, organize, plan, finance, direct, manage or supervise trafficking in stolen property, contrary to the provisions of N.J.S.A. 2C: 20-7.1;

In violation of  $\underline{\text{N.J.S.A.}}$  2C:5-2, and against the peace of this State, the government and dignity of the same.

(Fencing (Dealing in Stolen Property) - Third Degree)

on or about December 6, 2021, at the Borough of Shrewsbury, in the County of Monmouth, and at the City of Jersey City, in the County of Hudson, elsewhere, and within the jurisdiction of this Court, did commit fencing (dealing in stolen property) by trafficking in, or initiating, organizing, planning, financing, directing, managing or supervising trafficking in stolen property, that is the said QUAMIR HODGES; ZAQUAN T. WRIGHT; BURDLEY JEAN and ADRIAN GOOLCHARRAN trafficked in, initiated, organized, planned, financed, directed, managed or supervised trafficking in property of another having a value of more than \$500 but less than \$75,000, namely a 2018 Land Rover Range Rover, with a Vehicle Identification Number ending in "2577," contrary to the provisions of N.J.S.A. 2C:20-7.1b, and N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

#### COUNT SEVEN

(Receiving Stolen Property - Third Degree)

## QUAMIR HODGES

on or about December 22, 2021, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, did commit theft by knowingly receiving or bringing into this State moveable property of another, having a value of more than \$500 but less than \$75,000, that is, a 2016 Dodge Charger, with a Vehicle Identification Number ending in "2370," knowing the same to be stolen or believing that it had probably been stolen, contrary to the provisions of N.J.S.A. 2C:20-7, and against the peace of this State, the government and dignity of the same.

#### COUNT EIGHT

(Motor Vehicles; Removal or Alteration of Identification Number or Mark; Possession - Third Degree)

#### QUAMIR HODGES

between on or about October 27, 2021, and on or about December 22, 2021, at the City of Paramus, in the County of Bergen, and at City of Newark, in the County of Essex, elsewhere and within the jurisdiction of this Court, for an unlawful purpose, knowingly possessed motor vehicles, or any of the parts thereof, from or on which any trademark, distinguishing or identification number, or serial number or mark has been removed, covered, altered, changed, defaced, destroyed or obliterated, that is the said QUAMIR HODGES, for an unlawful purpose, knowingly possessed a 2016 Dodge Charger, with a Vehicle Identification Number ending in "2370," and a 2019 Dodge Durango RT, with a Vehicle Identification Number ending in "4826," valued at more than \$500, from or on which a Vehicle Identification Number decal had been altered, changed or defaced, contrary to the provisions of N.J.S.A. 2C:17-6b, and against the peace of this State, the government and dignity of the same.

## COUNT NINE

## (Possession of CDS - Third Degree)

## QUAMIR HODGES

on or about December 22, 2021, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, knowingly or purposely did possess a controlled dangerous substance, that is, FENTANYL, a Schedule II controlled dangerous substance; contrary to the provisions of N.J.S.A. 2C:35-10a(1), and against the peace of this State, the government and dignity of the same.

## COUNT TEN

(Possession of Prohibited Weapons and Devices - Fourth Degree)

QUAMIR HODGES

on or about December 22, 2021, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, knowingly did possess a firearm which has been defaced, namely a Sig Sauer SP2022 semi-automatic 9 millimeter handgun, contrary to the provisions of N.J.S.A. 2C:39-3(d), and against the peace of this State, the government and dignity of the same.

## COUNT ELEVEN

(Possession of Prohibited Weapons and Devices - Fourth Degree)

QUAMIR HODGES

on or about December 22, 2021, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, knowingly did possess a large capacity ammunition magazine, contrary to the provisions of N.J.S.A. 2C:39-3(j), and against the peace of this State, the government and dignity of the same.

#### COUNT TWELVE

(Receiving Stolen Property - Second Degree)

#### BURDLEY JEAN

between on or about December 20, 2021, and January 6, 2022, at the Cities of Union City and Jersey City, both in the County of Hudson, in the Township of South Brunswick, in the County of Middlesex, elsewhere, and within the jurisdiction of this Court, did commit theft by knowingly receiving or bringing into this State moveable property of another, having a value of more than \$75,000, that is, a 2022 BMW X5, with a Vehicle Identification Number ending in "9483"; a 2020 BMW X4, with a Vehicle Identification Number ending in "9114"; and a 2015 Land Rover Range Rover, with a Vehicle Identification Number ending in "5337," knowing the same to be stolen or believing that it had probably been stolen, contrary to the provisions of N.J.S.A. 2C:20-7, and N.J.S.A. 2C:20-2, and against the peace of this State, the government and dignity of the same.

#### COUNT THIRTEEN

(Motor Vehicles; Removal or Alteration of Identification Number or Mark; Possession - Third Degree)

#### BURDLEY JEAN

between on or about December 20, 2021, and January 6, 2022, at the Cities of Union City and Jersey City, both in the County of Hudson, at the Township of South Brunswick, in the County of Middlesex, elsewhere and within the jurisdiction of this Court, for an unlawful purpose, knowingly possessed a motor vehicle, or any of the parts thereof, from or on which any trademark, distinguishing or identification number, or serial number or mark has been removed, covered, altered, changed, defaced, destroyed or obliterated, that is the said BURDLEY JEAN, for an unlawful purpose, knowingly possessed a 2020 BMW X4, with a Vehicle Identification Number ending in "9114," and a 2015 Land Rover Range Rover, with a Vehicle Identification Number ending in "5337," valued at more than \$500, from or on which a Vehicle Identification Number decal had been altered, changed or defaced, contrary to the provisions of N.J.S.A. 2C:17-6b, and against the peace of this State, the government and dignity of the same.

## COUNT FOURTEEN

(Trafficking in Personal Identifying Information - Second Degree)

BURDLEY JEAN

on or about January 14, 2022, at the City of Jersey City, in the County of Hudson, elsewhere and within the jurisdiction of this Court, did distribute, manufacture or possess ten or more items containing personal identifying information pertaining to five or more separate persons, without authorization, and with knowledge that the actor is facilitating a fraud or injury to be perpetrated by anyone, contrary to the provisions of N.J.S.A. 2C:21-17.3B(2), and against the peace of this State, the government and dignity of the same.

## COUNT FIFTEEN

(False Government Documents - Second Degree)

#### BURDLEY JEAN

on or about January 14, 2022, at the City of Jersey City, in the County of Hudson, elsewhere and within the jurisdiction of this Court, did knowingly make, or possess devices or materials to make, a document or other writing which falsely purports to be a driver's license, birth certificate or other document issued by a governmental agency and which could be used as a means of verifying a person's identity or age or any other personal identifying information, contrary to the provisions of N.J.S.A. 2C:21-2.1b, and against the peace of this State, the government and dignity of the same.

#### COUNT SIXTEEN

(Forgery (Possession of Forgery Devices) - Third Degree)

BURDLEY JEAN

on or about January 14, 2022, at the City of Jersey City, in the County of Hudson, elsewhere and within the jurisdiction of this Court, with purpose to use, or to aid or permit another to use the same for purposes of forging written instruments, including access devices and personal identifying information, made or possessed any device, apparatus, equipment, computer, computer equipment, computer software or article specially designed or adapted to such use, contrary to the provisions of N.J.S.A. 2C:21-1c, and against the peace of this State, the government and dignity of the same.

## COUNT SEVENTEEN

(False Government Documents - Third Degree)

#### BURDLEY JEAN

on or about December 23, 2021, at the Township of South Brunswick, in the County of Middlesex, elsewhere and within the jurisdiction of this Court, did knowingly exhibit, display or utter a document or other writing which falsely purported to be a driver's license, birth certificate or other document issued by a governmental agency and which could be used as a means of verifying a person's identity or age or any other personal identifying information, contrary to the provisions of N.J.S.A. 2C:21-2.1c, and against the peace of this State, the government and dignity of the same.

## COUNT EIGHTEEN

(Credit Card Theft - Fourth Degree)

#### BURDLEY JEAN

on or about January 14, 2022, at the City of Jersey City, in the County of Hudson, elsewhere and within the jurisdiction of this Court, did take or obtain a credit card from the person, possession, custody or control of another without the cardholder's consent or, with knowledge that it was so taken, received the credit card with intent to use it or to sell it, or to transfer it to a person other than the issuer or the cardholder, contrary to the provisions of N.J.S.A. 2C:21-6c(1), and against the peace of this State, the government and dignity of the same.

#### COUNT NINETEEN

(Certain Persons Not to Have Weapons - Second Degree)

QUAMIR HODGES

on or about December 22, 2021, at the City of Newark, in the County of Essex, elsewhere and within the jurisdiction of this Court, after having been convicted of first degree Robbery, N.J.S.A. 2C:15-1A(2), under Union County Indictment No. UNN-12-003869-003, knowingly did purchase, own, posses's or control a certain weapon, that is, a Sig Sauer SP2022 semi-automatic 9 millimeter handgun, contrary to the provisions of N.J.S.A. 2C:39-7b, and against the peace of this State, the government and dignity of the same.
